Officers PERRY, BOWDER and BURTON attended site on 14/07/17. Met with Janet Rawlings, Environment and H&S Manager. Tour of site was given, previous non-compliance relating to pooling of waste water has been rectified and relevant operational measures have been put in place.

Discussed reports of waste plastics allegedly going into surface water drains. Janet Rawlings informed us that in a period of her absence, operational techniques differed and a 'back door' was left opened. However this was a one-off situation and Janet assured that the relevant staff have been spoken to regarding correct operational techniques. Janet also assured me that a strict cleaning schedule of the drains will be implemented for the future, in order to prevent any incidents of this sort. As no evidence was found of plastics in the river, and Roydon's robust maintenance of the drainage, no breach has been scored.

Thank you for your ongoing commitment to compliance, and I look forward to working with you in the future.
