At 14:00 on 18th April 2018 your site was visited as part of a series of scheduled site visits to plastic waste handling facilities across Wales, regarding assessing the implications that the new China Imports Ban will potentially have on plastic waste streams. Your new regulatory officer, Richard Palmer, was in attendance along with fellow officer Jonathan Lee and Senior Environment Officer Lara Moggridge. Thank You for taking the time to demonstrate your activities on site. Your operations consist of a Plastic Bottle Recycling operation into saleable plastic product.

C4 - Storage, handling, labelling and Segregation - No breaches recorded

At the time of the site visit, waste product was being efficiently sorted, labelled and stored correctly within the agreed permitted area. As discussed, the China import ban is having an impact on your outlets for certain waste streams. This means some stockpiling is occurring within the site. Although capacity was nearly being reached, contingency plans were in place and NRW had no reason to believe that any breaches would occur. New outlets were actively being sourced to clear the backlog of plastic waste building up on site and NRW were reassured that the build up will be cleared before stockpiling becomes a potential issue. No waste was being stored outside.

G4 - Reporting and notification - No breaches recorded

All waste returns are up to date and in compliance.

The Fire Prevention and Mitigation Plan (FPMP) guidance was discussed. It is recommended that you review the guidance against your activities so that you can produce a plan in line with the guidance. Although your permit does not yet require an FPMP, it is likely your permit will undergo an NRW variation in the near future to require one. The guidance can be found at the link:
