Following a site inspection of the yard, I could see continued improvement of waste stored on site. It was noticed that some skips filled with general waste had been temporary stored outside the permitted area on the un permitted part of the plot. I remind you that no waste is to be stored in that area.

I have breached you for the plasterboard that was seen deposited on the ground adjacent to the inert waste pile.

This breach was over 3 conditions as follows

A1. Specified activities. Breach of condition 1.1.1 Plasterboard being stored other than that stipulated within the permit.

B4. Containment of stored Materials. Breach of condition 2.3.1. Waste namely Plasterboard only be handled and/or stored on site in accordance with specified conditions.

C4. Storage and segregation. Breach of condition 2.3.1 as above.

I am giving advice and guidance under these circumstances. You must ensure that all wastes are correctly stored and handled. Plasterboard must be stored in a separate covered container and correctly disposed of. It must not be mixed with other general waste. You must comply with this immediately.
