Inspection of Rhiwsaeson WWTW on 6/04/2022. Weather was dry.

Storm tanks / overflow not in use at time of visit so unable to assess associated conditions.

Site appeared well maintained. Logs of daily maintenance and sampling seen, all up to date.

Discharge location needs reviewing with permit being varied to reflect correct discharge point.
