3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

Routine sampling from 7/3/2022 provided two significant failures for your permitted discharge - namely Ammonia at 29 mg/l (Limit: 11.6 mg/l) and Phosphate at 18.3 mg/l (Limit: 3.5 mg/l). Therefore you are in breach of your permit conditions. Given the sensitive nature of the Afon Tarrell and it's flow into the River Usk immediately downstream, this has been categorised as a C2 offence, especially with the recent issues of Phosphates within the Usk SAC.

Please consider your operations and bring the discharge back into compliance. I will be visiting the site to discuss with you further.
