Quarter one (January – March 2022) waste returns.

NRW received Harps waste returns for quarter one on the 22nd April 2022. Harp received a total of 3.0984 tonnes of waste EWC 140601. A total of 15.63 tonnes of waste was removed from site.

Harp had identified some corrections for information in the previous CAR (CAR_NRW0039714). The Oil tank is a 2000 litre tank not 5 tonnes. The incidents mentioned occurred during February and April 2021 and Harp have not had any spillage incidents this year.

All returns are compliant and accepted.
