4. Details of our assessment

The permit for GTR Aggregates and Recycling Ltd was partially suspended on 30th March 2022. This suspended the permit for all incoming wastes. The site was still permitted to treat and remove waste.

On 25th March 2022, Natural Resources Wales received a report stating that the site was continuing to accept waste, despite the permit being suspended for this activity. Therefore, Waste Regulation Officers, Sarah Walton and Kathryn Bradshaw, visited site to follow up this report.

Officers attended site on Tuesday 26th April 2022 to conduct an unannounced inspection. Jamie Roberts (site manager) greeted officers and the nature of the report was discussed. Jamie understood that the site permit was suspended for incoming wastes. Jamie explained that at least 2-3 lorry loads of Household, Commercial and Industrial wastes were being removed from site each day. Given that at this point the permit had been suspended for nearly a month, it was surprising to officers that there was still waste on site, if this volume was being removed each day.

The above photograph shows food waste still being stored on site within the blue and black bin bags. This continued to give off a bad odour and is a clear breach of permit conditions and suspension notice requirements. This food waste should be removed from site and evidence of its removal (i.e. Waste Transfer Notes), should be submitted to NRW.

The permit suspension notice contained a number of steps and actions for GTR to complete, along with associated deadlines. A number of these deadlines have not been met and as such, is a breach of notice. It is an offence under Regulation 38(3) of the Environmental Permitting Regulations 2016, to not comply with an enforcement notice. NRW Officers are continuing to liaise with site management regarding this matter.

No waste was observed coming into site on this occasion. Officers had a brief look around site to visually check on volumes and types of waste being stored and treated.

Investigations will continue into waste acceptance onto site. A member of staff indicated to officers that waste was still being accepted on site.
