4. Details of our assessment

On Tuesday 26th April 2022, a routine inspection was carried out by Waste Regulation Officer, Sarah Walton.

On a previous site inspection in November 2021, it was found that inert waste was being crushed and screened. Treatment of waste is not authorised by the site permit. Therefore, a notice was issued instructing that all treatment should stop. The site was also at the limits for total volume that could be accepted onto site.

William Lewis (Permit Holder) accompanied Sarah throughout the inspection.

Upon entry to the site, there was a sign on display at the entrance, stating the site was closed for the tipping of inert wastes. There was no activity taking place on site and most of the machinery had been removed.

A walkover of site was completed. It was clear that progress had been made with the groundworks for the golf course. The above photographs show how the soil and stone material has been levelled and shaped.

William explained that all treatment of waste had stopped. However, there was some waste that was still being stored on site, such as concrete and bricks, that required treatment before they could be used on site to assist with the formation of site drainage. It was explained that in order to treat waste (ie.crushing/screening), a permit variation should be sought. The application process can take a number of months and there is no guarantee a variation will be granted. Separate advice on this will be sent via email.
