## 4. Details of our assessment

Q1 2022 monitoring results were submitted to NRW on 19 April 2022 in accordance with Condition 4.2.3.

### **Air Emissions - Emission Point A1**

Continuous air emissions monitoring (CEMS) was undertaken in accordance with Condition 3.5.1.

No Half Hourly or Daily Average ELVs for HCl (mg/Nm<sup>3</sup>), NH<sub>3</sub> (mg/Nm<sup>3</sup>), TOC (mg/Nm<sup>3</sup>), NO<sub>x</sub> (mg/Nm<sup>3</sup>), SO<sub>2</sub> (mg/Nm<sup>3</sup>), N<sub>2</sub>O (mg/Nm<sup>3</sup>) and Particulates were exceeded during Q1 in accordance with Condition 3.1.2.

Emissions to air (Emission Point A1) for CO (mg/Nm<sup>3</sup>) show no 10 minute (ELV 95th percentile) or Daily Average ELV exceedances in accordance with Condition 3.1.2.

### **Performance**

Q1 Operating hours - 2009 hours were recorded with no periods of abnormal operations.

### **Residues**

Bottom Ash and APC residues sampling was undertaken in accordance with Condition 3.5.1. Bottom Ash composition for Q1 remained below the 3% TOC limit at 0.62% in accordance with Condition 3.1.2.

### **Waste Returns**

Waste returns were received in accordance with Condition 4.2.5.
