## 4. Details of our assessment

Bio-aerosol monitoring was undertaken in accordance with Condition 3.7.1. The permit requires bioaerosol monitoring to be undertaken twice a year.

Monitoring was undertaken on 31 March 2022 and the results submitted to NRW on 5 May 2022.

Table S3.1 specifies limits for bio-aerosol concentrations as:

- Total bacteria - 1000 cfu/m<sup>3</sup>
- Aspergillus fumigatus - 500 cfu/m<sup>3</sup>
- Gram negative - 300 cfu/m<sup>3</sup>

Bio-aerosol concentrations were below the above limits at all sampling locations during this monitoring exercise.
