4. Details of our assessment

Bio-aerosol monitoring was undertaken in accordance with Condition 3.5.1. The permit requires bioaerosol monitoring to be undertaken twice a year.

Monitoring was undertaken on 31 March 2022 and the results submitted to NRW on 5 May 2022.

Table S3.4 specifies limits for bio-aerosol concentrations as:

- Total bacteria (TB) - 1000 cfu/m³
- Aspergillus fumigatus (AF) - 500 cfu/m³

Bio-aerosol concentrations were below the above limits at all sampling locations during this monitoring exercise.
