The following reports were assessed for the purposes of this compliance assessment report:

Annual Review of Fugitive Emissions.

Requirements - Condition 4.1.4 states that the operator shall review fugitive emissions, having regard to the application of best available techniques, on an annual basis, or such other period as shall be agreed in writing by the Agency, and a summary report on this review shall be sent to the Agency detailing such releases and the measures taken to reduce them within 3 months of the end of such period.

Findings - The summary report received indicates that general level of fugitive emissions remain low and that there is little the operator can do further to reduce or minimise emissions. This will be reviewed during the next site audit.

Annual Emissions Reporting (Jan - Dec 13).

Requirements - Condition 4.1.2 states that the operator shall, unless otherwise agreed in writing, submit reports of the monitoring and assessments carried out in accordance with the conditions of the permit.

Findings - Reporting of monitoring emissions to air conducted on the 22nd March 2013 indicate the site is well within the permitted emission limit value for total particulates.

Summary of Annual Improvement Targets.

Requirements - Condition 4.1.5 states that where the operator has a formal environmental management system applying to the permitted installation, which encompasses annual improvements targets the operator shall, not later than 31 Jan each year, provide a summary report of the previous year's progress against such targets.

Findings - No issues.

Site Closure Plan.

Requirements - Condition 2.11.2 states, notwithstanding condition 2.11.1 of the permit, the operator shall carry out a full review of the site closure plan at least every 4 years.

Findings - As a general overview of potential site closure the document submitted (April 2014) is acceptable. Natural Resources Wales would expect to see more detailed proposals if / when site closure is effected.

Recommendation: We would also advise that the current closure plan is amended to contain a record of any significant pollution incidents (including any remedial actions) that occur on site and plans detailing site layout / drainage or changes thereof.

Incident Management Plan.

This was reviewed as part of the annual submissions and found to be comprehensive in it's listing of potential major incidents on site, no issues were noted as part of the review.

No breaches of environmental permit requirements are noted and no further actions are required.
