Company Update:

The name of the company operating the site has changed from Vion Agriculture Ltd to 2Agriculture Ltd earlier this year, shortly followed by a change in registered offices also. Natural Resources Wales were formally informed of these changes in writing as required by the environmental permit. Company structure, site management and staff remain largely unchanged as a result, site operations have continued as usual.

Note: If you wish to have the permit updated to reflect the above changes you may wish to apply for an administrative variation to note the new company name and registered address.

Site Update:

The scrubber on the feed mill received some major investment in early 2013 with the replacement of packing media and demisters, plus the replacement of the fan on the system. All works were completed as planned and no issues have been noted with the system since it was recommissioned.

Preventative maintenance on the site concrete hard standing is ongoing, with some works being carried out at the time of the visit.

All 6 of the raw material storage silos on site have also been identified for maintenance to the concrete support bases. Some trials of the best method for strengthening the bases has already been carried out. The works will be scheduled sometime in 2014 and planned around the silos being empty of raw materials.
