This was the first inspection carried out whilst the site has been operational. An inspection was carried out by Environment Officers Rhys Ellis and Aled Zachary.

We firstly had an update from the site manager and site supervisor on how things are proceeding on site. Today the plant was not running due to an electricity input problem.

In summary the plant was signed over to FCC on the 14th May 2015. The mechanical biological treatment facility is now treating waste. Recyclable material is taken out by the mechanical process. Site are still looking into offtakes for the recyclables. The treatment kit is currently being fine-tuned to improve the output standards of the recyclables.

The biological treatment (Bio drying) is now also operational.

A1) Permitted activity

As previously discussed with FCC, the site is likely to be falling under the Industrial Emissions Directive and FCC would require to vary their permit. However to date we have not received an application from you.

Please can you confirm when we can expect the application. Our permitting centre are requesting that you apply as a matter of urgency to enable them to duly make, determine, consult and issue a consolidated permit by the July 7th 2015 Deadline.

Failure to submit a suitably detailed application with the associated fee will mean that these sites may not have a permit to cover the relevant activity controlled by the Industrial Emissions Directive after the 07 July 2015 deadline.

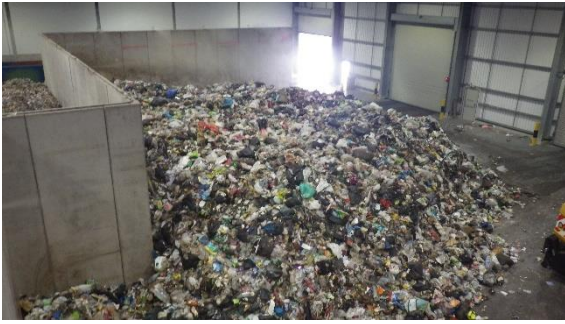

G) Monitoring of emissions and environment

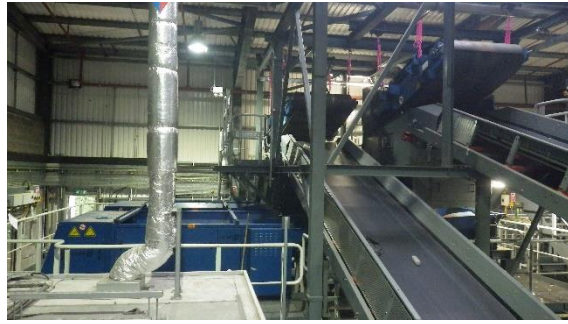
As per permit condition 3.4.1 of the permit - bio aerosol monitoring is required.
