Review of monitoring and reporting for January to June 2015

Monitoring was carried out as required by the permit and reports were submitted on time.

Four part As were submitted during the six month period, for a fire on 27th February and for breaches of permit limits on 02/02, 28/05 and 01/06.

Suspended solids was measured as 174mg/l against the limit of 50mg/l on 02/02; BOD was reported as 80mg/l on 01/06 and an elevated temperature was reported on 28/05 when it went above the 25°C limit.

The Quarterly report form for Q1 also included a breach of BOD limit on 02/02 which was not reported at the time.

A Part B has been received for the February event, but not for the May or June events. These should be provided without delay - **Action**

The breaches of permitted limits have been recorded as a single Category 3 non-compliance, and the failure to report the high BOD has been recorded as a Category 4 non-compliance.

Uncertainty data is still not included in the quarterly reports. This was raised at the monitoring audit last October and a recommendation was made to ask the external lab to include this information when they provide the results - **Action**
