Improvement Condition 2 - an extension has been granted until the end of March 2017 for the completion of this improvement condition. Until the proposed new bund is in place the Operator must ensure that the additional control measures highlighted in response to improvement condition 1 are in place.

Part B

A provisional Part B was submitted on 5 Feb 2017 in relation to the drainage issue highlighted in December 2016. A final Part B should be submitted once the investigation is complete.

Returns

The initial responses were received on 7 February but some information was missing / incorrect, which was submitted on 23 February 2017. The submissions were outside of the timescales specified in the permit and the Operator shall ensure that there are adequate procedures within the site's EMS to secure compliance with the reporting section of the permit.

Breach permit condition 4.2.2 and 4.2.3, category 4.

No emission limit values are set within the permit.

The Operator shall be mindful of the conditions in section 3.3 of the Permit and ensure that adequate procedures are in place to secure compliance. There appears to be a number of inconsistencies in the permit in relation to monitoring to sewer which will be amended as part of the next permit variation.
