This CAR form is in response to the proposals received in relation to Improvement Condition 2 within the Environmental Permit.

The Operator provided details, on 25 November 2016, of the proposed secondary containment for the bunding of all raw material, product and waste on site.

The bunds around the tank farm area will be reinforced concrete, skimmed with a render that is resistant to the juices stored within them. Bund 1 is 110% of the tank within it plus an allowance for rainwater and surge. Bund 2 contains 10 vessels and the proposed size of the bund is greater than 110% of the largest container and greater than 25% of the total capacity, as per the relevant guidance.

A procedure exists that covers the ongoing assessment of the secondary containment once they are constructed. All checks and emptying of bunds will be documented.

The request by the Operator to extend the deadline to the end of January 2017 is granted.

The Operator shall ensure that all of the additional checks highlighted in their response to Improvement Condition 1 (and in response to the recent audit findings) are carried out and documented until the proposals under improvement condition 2 are complete.

Confirmation shall be provided to Natural Resources Wales on completion of improvement condition 2.
