4. Details of our assessment

The non-compliance listed above was identified during our annual 2021 data audit. This audit addressed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring conditions, UV conditions (only applicable at some sewage treatment works) and Urban Wastewater conditions (only applicable at some sewage treatment works).

Please note: this car form is dated 31st of January 2021 as these non-compliances relate to annual 2021 data. However, for clarity I carried out the compliance assessment on 19th of April 2022.

Permit condition Breach :3.3.1 The operator shall unless otherwise agreed by Natural resources

Wales undertake the monitoring specified in the tables in schedule 3 to the permit.

Breach: sample shortfalls: 6 sample shortfalls, 4 totals available as DCWW monitoring for free chlorine in error.
