Llwyn Isaf Annual Environmental Report 2021 - Review

Permit Requirement:

4.2.2 A report or reports on the performance of the activities over the previous year shall be submitted to Natural Resources Wales by 31 January (or other date agreed in writing by Natural Resources Wales) each year. The report(s) shall include as a minimum:

- (a) a review of the results of the monitoring and assessment carried out in accordance with this permit against the relevant assumptions, parameters and results in the risk assessments submitted in relation to this installation and any agreed amendments thereto;
- (b) the energy consumed at the site, reported in the format set out in schedule 4 table S4.3
- (c) the annual production/treatment set out in schedule 4 table S4.2;
- (d) the topographical surveys required by condition 3.5.3 other than those submitted as part of a CQA validation report;
- (e) an assessment of the settlement behaviour of the landfill body based on the difference between the most recent topographical survey and previous annual topographical survey for the areas of the landfill which did not receive waste between the surveys;

Summary:

Leachate heads have remained in compliance for the year. No Groundwater compliance limits were breached in 2021 and surface water quality in the river Desach, showed no impact from the landfill. Methane concentrations in external gas monitoring wells remained below trigger levels with only one minor breach for Carbon Dioxide.

Since peaking between 2016 and 2020 the Ammoniacal Nitrogen and chloride levels in the leachate have reduced dramatically which is an encouraging trend.

There are 5 gas wells showing greater than 15% O₂. Please check the sealing on these wells as they are close to ambient levels.

Flare emissions and bulk gases have been reported separately on this occasion. This should be integrated into all future reports.

A topographical survey is required by the above permit condition as below:

- (d) the topographical surveys required by condition 3.5.3 other than those submitted as part of a CQA validation report;
