Annual Reporting - Period 2021

An annual report was provided on 27/01/2022 for the 2021 period in accordance with Permit Conditions 4.1.2, 4.1.3, 4.1.4 and 4.1.5. This contained a summary of monitoring, performance indicators, environment management system targets and fugitive emissions as required.

Emissions monitoring was carried out on 21/04/2021. All monitored parameters were within the relevant emission limit values specified in the permit apart from Formaldehyde as documented in previous Compliance Assessment Report (Ref. CAR_NRW0038542).
