4. Details of our assessment

LLANDDULAS SITE PERIMETER ODOUR INSPECTION

Thursday 28th April

Following an odour complaint from a local resident, NRW undertook a perimeter site odour inspection in the area of the complaint on the 28th April 2022. A timed odour detection exercise was undertaken directly down wind of the prevailing wind coming off the site. No odours were detected during either of these exercises.

Site Management conducted an internal investigation following the complaint and reported that the gas extraction system and extraction/combustion plant were operating normally and no off-site odours were detected.

The permit conditions relating to odour compliance for the landfill site are reproduced below:

3. Emissions and monitoring**3.1 Emissions to water, air or land**

3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 4 tables S4.2, S4.3 and S4.4.

3.4 Odour

3.4.1 Emissions from the activities shall be free from odour at levels likely to cause annoyance outside the site, as perceived by an authorised officer of the Agency,(NRW), unless the operator has used appropriate measures to prevent or where that is not practicable to minimise the odour.

On this occasion there were no breaches of these conditions. Please ensure that site continues to comply with permit conditions and follow all agreed procedures.
