As per emails between Dr. Michael Gerardo and Sarah Atkinson of 21st-22nd March 2019, DCWW had the required data but did not submit it. (Michael Gerardo's email of 22/3/19 stated: '[something happened between the data extract from the database and the generation of the file for submission. For some reason that specific data for aluminium did not transfer over.](#)'

Therefore NRW are counting it as a late submission, as the permit requires it at least quarterly.

- The guidance says: Reporting routine OSM monitoring data For OSM the requirement is that all available completed monitoring data is reported on a quarterly basis. We would not normally expect to be recording CCS non compliance unless there is a significant problem with the reporting of monitoring data. If there are repeated problems with the timeliness of reporting then we may record a CCS category 4 or potentially a category 3. The breach would be scored under g4 against condition OSM9 for each relevant discharge.
