This is a CAR form in relation to only 11 samples of Total Iron (Fe) being provided with the 12th sample being tested for Dissolved Iron not Total Iron. Under permit number AN0249201 Rhiwsaeson Sewage Treatment Works, this falls under the breach of the current permit particularly Operator Self Monitoring (OSM) requirements.

Condition Breach

4.2.2 Within the time period after the end of the reporting period specified in schedule 4 table S4.1 the operator shall, unless otherwise agreed in writing by Natural Resources Wales, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit, as follows:

- (a) in respect of the parameters and monitoring points specified in schedule 4 table S4.1; (Reporting or Monitoring Data)
- (b) [for the reporting periods specified in schedule 4 table S4.1 and] using the forms specified in schedule 4 table S4.2;

In addition, under OSM conditions, this breach falls under OSM1 which is consent holder, shall unless otherwise agreed in writing by the Agency undertake a monitoring programme for parameters specified by this consent which control the effluent quality by numeric limits at not less than the frequencies specified.

Action

1. Ensure sampling/monitoring regime is robust to avoid dissolved iron being analysed instead of Total.
2. 12 samples to be submitted for 2019.
