Introduction

The visit was undertaken as part of the EPR Permit compliance regime and to ensure that the company are operating within the permitted conditions.

Review of new BREF Permit

The company have recently been involved in permit review following the recent review of the Non-Ferrous Metal BREF Review. The review has outlined several Best Available Techniques (BAT) conclusions and the operating companies must ensure compliance with the conditions with 4yrs of the issue (June 16) of the EU BREF Note.

The permit was reviewed and issued on the 16th of October 2017. The company did not require any derogations for the BAT conclusions and as a result the company will have updated emission monitoring and reporting from June 2020.

The permit does include an improvement condition (IC9) that requires the company to report annually emissions of nickel to air and improvements made to minimise the releases and submit the report to NRW every August. This work will feed into the ongoing work with Welsh Government on improving air quality and compliance with EU air quality target levels.
