On 2 July 2018 Valero detected a leak of diesel from a filter pot located prior to a flow meter located within the Jetty operations. The release was quickly isolated by Valero and notified to Natural Resources Wales in accordance with permit conditions. The subsequent Part B follow submission was received 14 November 2018.

The incident released a quantity of diesel, estimated up to 75 litres, directly into the Milford Haven; a designated Special Area of Conservation. This release to surface water, from an unauthorised discharge point was in breach of Condition 3.1.1 of the Environmental Permit. NRW received no reports of any wider scale impact on the waterway, beaches and wildlife because of this particular release. In accordance with our Compliance Classification Scheme this unauthorised release has been classified as a minor environmental impact - CCS3.

The root cause of this diesel release may be investigated further by Natural Resources Wales.
