On 1 July 2018 Valero detected a leak of gasoline from a (slop) pipeline located at the jetty. Once detected the gasoline transfer was stopped and the pipeline quickly isolated. Valero notified Natural Resources Wales of this release in accordance with permit conditions. The subsequent Part B actions were reported to NRW on 14 November 18.

The incident released a quantity of gasoline, estimated up to 75 litres, directly into the Milford Haven; a designated Special Area of Conservation. The release to surface water an unauthorised discharge point in breach of Condition 3.1.1 of the Environmental Permit was limited to the vicinity of the jetty and no wider impacts were reported to NRW. No reports of pollution of the wider Milford Haven waterway, beaches or wildlife were reported to NRW. In accordance with our Compliance Classification Scheme this unauthorised release has been classified as a minor environmental impact - CCS3

At the time of writing the report, the pipeline has been taken out of use no further action is required.
