On 10 November 2018 during a period of intense rainfall, high oil in water results were recorded on the Pwllcrochan weir discharge (W2) and on an emergency discharge at the west reservoir (W3). The results were observed as 8 and 6 mg/l against limit values for each release point of 5 mg/l.

As these breaches were during intense rainfall and there was no observable environmental impact the score assigned is a CCS4. These results were reported on 10/11/18 so that aspect was compliant (G4).
