Sensient has submitted its bi-annual returns for Q1 and Q2 2015 on 6 May 2016. There is a requirement in the permit for the operator to submit monitoring data every 6 months for air and water (effluent transfer) and for these to be submitted within 28 days of the end of the reporting period i.e. 31 July 2015 (section 4.1.2 of Sensient's environmental permit).

Sensient is also required to notify NRW without delay of the detection of an emission of any substance which exceeds any limit in the permit specified in relation to the substance (section 5.1.1 of the permit).

Air emissions

Based on the figures provided in the submission, there have been the following breach:

Each breach will be scored against the quarter it breached the permitted limit, therefore there will be four breaches recorded on NRW's compliance classification scheme (CCS) database, each attracting a category 3 score (minor impact) for emissions to air. The limit breach for particulates at A7 was reported and a CAR form was issued 28 April 2015 (ref 5867).

Sensient has not submitted their reporting within 28 days of the end of the reporting period and are therefore not compliant with permit condition 4.1.2 and this will be scored.

Conclusion

Sensient have failed to report their emission data as required by the permit. The submission of emission data bi-annually and to report any breaches of permitted limits has in most cases, been absent. This is considered a management failure and therefore a breach will also be given.
