2016 Engine Emission Monitoring Results and Permit Limits

The permit specifies that the gas engines are subject to annual monitoring for: Oxides of Nitrogen (NO_x), Carbon Monoxide (CO), Total Volatile Organic Compounds (VOC's).

There are currently two gas engines sited at Tir John. One *Jenbacher* J320 (820kW) and a smaller *Jenbacher* J208 (330kW). However only one engine is now in use (J320) and only this has been emission tested.

On the 9th March 2016 the annual results for 2016 were submitted that confirmed that the annual test results were within the limits specified in the permit (or within the overall uncertainty permitted (see LFGN08)).

No Flare emission testing was undertaken in 2016 as the flare was only operational for 1.5% of the time over the preceding 12 months. The permit only requires flare emission testing when the unit is in use for a period greater than 10%.

Please note that there is a typographical error in this report due to a defect in our compliance reporting system. In Section 1 on the preceding page, the entry which states:

"G4 - Monitoring and Records, Maintenance and Reporting - Reporting and notification to the Environment Agency" should read "G4 - Monitoring and Records, Maintenance and Reporting - Reporting and notification to the Natural Resources Wales"
