4. Details of our assessment

Nexperia, as part of their planned business expansion, wish to install and operate seven thermal processing units (TPUs) to treat emissions from the manufacturing process. An application to add these units to their existing EPR permit has been submitted, but the permit is unlikely to be issued before Nexperia need to start operating them.

The emissions from the TPUs will be discharged through existing, permitted, emission points A13 and A14. No monitoring requirements or emission limit values have been set in the permit for these two emission points. Nexperia have assessed the effect the additional emissions could have on the discharges from A13 and A14 using an H1 assessment. The flow will be increased by 0.13% but all substances screened out as not significant. There is unlikely to be any effect on the concentration of substances discharged to air from A13 and A14 due to the operation of the additional TPUs.

Natural Resources Wales will allow Nexperia to operate up to seven new TPUs for a period of six months from 16th May 2022 to 16th November 2022 while the permit determination and issuing process is being carried out. If, after this time, the varied permit has not been issued, Nexperia should seek further guidance from Natural Resources Wales.

Natural Resources Wales reserve the right to withdraw such permission if any issues arise pending determination of the permit variation.
