Summary

The quarterly in waste and external monitoring results show a relatively stable position with suction pressures and gas concentrations low.

There is one external borehole (BH3) with a breach of 2.1% for methane. This is a reduction in migration concentrations from previous data and represents a very low risk and on this occasion will not be scored.

BH6 is damaged and this should be repaired if possible. Please submit a plan for repair by the 30th May 2022.

Finally, the where balance gases are greater than 50% please consider a well sealing programme where the air is leaking proximal to the well. There are a number of wells showing ambient levels of balance gas (circa 79%) and these should be targeted first for air leaks in the well head.
