### **Introductory note**

**This introductory note does not form a part of the notice.**

The following notice gives notice of the variation and consolidation of an environmental permit.

The operator has applied to make a substantial variation to the current environmental permit. This variation, changes technical specification of the plant (CHP engines, digesters) and feedstocks. The plant will no longer accept animal by-products as a feedstock, instead primarily dairy DAF effluent, glycerol, chicken litter and maize & rye silage will be used instead. The permit boundary has also been increased in this variation to allow use of the land for a larger plant.

The schedules specify the changes made to the permit.
