The Company has been purchased by Bimeda but still retains the same company registration.

The Operator was advised to notify Natural Resources Wales of any changes to the registered company in accordance with Condition 5.1.5 of the Permit.

Inspection

Housekeeping was good throughout the inspection. Records of the oven afterburner temperature were inspected and showed that it remains above the 800 degrees Celsius. This is validated by a second thermocouple. Local exhaust ventilation and abatement was inspected during the site visit. The abatement for system 4 which extracts air from the raw material mixing and heating crucible for glass production was inspected. This collection unit below the filters was noted to be full of dust collected from the filtration system. The Operative was aware that this required emptying and the unit had ceased operation for the day. This was reportedly checked for emptying on a weekly basis. **The Operator was advised to ensure this is emptied as overfilling could cause spillages and render the air filtration system less effective.**

The air extraction and abatement system for glass grinding, weighing room and oven were also inspected.

The Low Impact installation reporting form was presented during the site visit.
