4. Details of our assessment

This was an unannounced, routine site inspection. Officers were accompanied by the Site Manger during the visit.

Engine 2 had been repaired since the last site inspection and was operational. Engine 1 was in working order but was not operational at the time of the inspection.

The outstanding action (Action 1) raised in CAR_NRW0039794 was discussed. The Site Manger explained that they were in the process of sourcing adequate secondary containment e.g. bunding, drip trays, for drums/ Intermediate Bulk Containers (IBCs) containing potentially polluting substances stored within the gas compound. I remind you of the deadline (27.05.22) for completion of this action (B4-O).
