4. Details of our assessment

This was an unannounced site inspection by Hazardous Waste Regulation Officer, Kathryn Bradshaw. I was accompanied around site by the owner, Derek Pilkington.

The permitted area building was undergoing a clear out of equipment but the sealed locked skips were present inside the building in good condition. There were no ongoing waste activities on site at the time of the inspection.

The site was fully secure and well maintained. PARS Ltd continue to use Acumen Waste Services Ltd to collect the asbestos waste. I viewed two recent consignment notes for the collection of this waste, they were fully completed with the Part E attached.

A review of the waste returns and consignee returns for 2021 was completed for the site, all were in order with no issues.

On a review of the waste returns for the site I noticed that the certificate of continuing competence for Derek Pilkington had expired in March 2022. But Derek Pilkington had completed the course at the beginning of March 2022 and I was provided with his new certificate which expires on 01/03/2024.
