4. Details of our assessment

This was a routine, unannounced site inspection. Officers were accompanied by the Site Manger during the visit.

There was no activity at the Materials Recycling Facility (MRF) and there was no waste stored within the building.

Outside of the MRF building there was a metal storage container which contained fly ash and incinerator bottom ash from the Small Waste Incineration Plant (SWIP) (discussed in CAR_NRW0039582 and CAR_NRW0039627). This waste was awaiting removal from site. The Site Manger confirmed that there was a slight delay with the removal of this waste but that it would be consigned as hazardous waste and taken to a site authorised to accept it.
