Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation and consolidation of an environmental permit.

This variation makes several pre-operational changes to the installation;

The operator has installed an expansion flap to the flue gas side of the boiler, this is an emergency pressure relief system and won't be in continuous operation.

The installation does not intend to operate an on-site IBA reprocessing facility at this time but instead has a dedicated area to store the IBA prior to removal from site and treatment at an off-site location. However, the actual listed activity is retained in the permit in case WTI wish to process IBA on-site in the future.

A flue gas sampling point has been added in addition to the currently sited sampling point on the stack.

The acid gas abatement system now utilises a dry lime injection system rather than a semi-dry system.

The operator has altered the NO_x abatement system by using Flue gas recirculation, advanced secondary combustion will also be utilised on-site, there will be no changes to the performance of the system and currently permitted ELV's will be achieved.

The technology provider has also been changed by the operator. This means that a new boiler and turbine will be installed. The new system provides better efficiencies and increased throughput (currently permitted throughput levels will be maintained).
