On the 10th of August, NRW visited Aberllefenni slate works and did not see any evidence of Hydro Electric generation. Please could you confirm whether the abstraction license for power generation is online and that there is or is not a hydroelectric power scheme on site.

Please be mindful of condition 9.11 which states: "This licence shall cease to be of any effect if the abstraction it authorises has not commenced within 3 years of the license issue date."

The licence was issued in April 2013 and was transferred to your name in July 2016.

Please email the local water resources officer to confirm or deny these findings.
