### 3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

### 4. Details of our assessment

This was an unannounced, routine site inspection. Officers were accompanied by the Site Manger during the visit.

The operator recommenced waste acceptance into the landfill on the date of the inspection (03.05.22), after a period of inactivity. Officers witnessed waste tipping activities and reviewed a selection of completed waste transfer notes for waste tipped earlier that day. Wastes included EWC 19.12.12 - mechanically treated wastes and 20.03.01- mixed municipal waste.

Photographs of daily cover placed over the waste were sent to NRW following the inspection.

Officers observed that a significant amount of off-specification compost from the composting permit (CB3834RQ) remains deposited on top of the landfill cap (as discussed in the previous inspection report CAR\_NRW0039829). Off-specification compost is not yet permitted to be stored on the cap or used in restoration of the landfill as it is still subject to approval by NRW via a pre-operational condition of the permit

This is regarded as an ongoing issue and has not been scored on this occasion (A1-O).

NRW will review the following document 'Addendum to Waste Recovery Plan, Restoration Soil Upper Profile- Bryn Posteg Landfill, Pre-production Declaration of Compliance BS3882:2015 Version 3 April 2022' and confirm our assessment in a separate CAR.

Action 1: No more off-specification compost should be brought onto the cap and off-specification compost should not be used in restoration of the landfill until the operator receives written approval from NRW.

There was construction activity near the site entrance. The operator explained that they were installing a new drain.

The Small Waste Incineration Plant (SWIP) was not operational at the time of the inspection. Officers witnessed a vehicle tipping fuel for the SWIP into the walking floor

bunker. Overall, the quality of the fuel was acceptable but small amounts of contamination were identified e.g. wrapping, plastics.

Leachate levels in the treatment lagoon and balancing lagoon were low with adequate freeboard maintained.

Officers observed several large holes in the south west boundary fence. During the inspection, cattle from the adjacent field came onto site through these holes. Officers also observed hoof prints on the path (western area of the site). The presence of cattle on site is a potential environmental risk to surface water (excrement) and gas management (damage to gas infrastructure). The holes also present a means of unauthorised access to members of the public. NRW considers this a breach of permit condition 1.1.1 (D1-CCS3).

Action 2: Repair the site boundary fence to ensure there is no unauthorised access to the site. Provide NRW with evidence (photographs) that this has been completed by the specified date.
