This compliance report covers the visit made to Brookhill Landfill Site to assess the actions taken following a full site gas audit on 23rd October 2013. Full details are contained in the visit report.

Permit non-compliance

Condition 2.9.1 - Use of appropriate measures to control the migration of landfill gas. There has been an improvement in the collection of landfill gas from the site since the audit, but there are still too many wells that are turned off and areas of the landfill that are not covered by the extraction infrastructure. This increases the risk of migration of gas from the site.

Condition 3.1.1 - Emissions shall only be from designated emission points. There were localised fugitive emissions of gas on the western flank of the site. These had been identified in the audit, but no action appears to have been taken. There was also a considerable release from leachate extraction well R4 (>4% Methane) with strong odour in this area. This was thought to be the source of a slight landfill gas odour off site near perimeter monitoring well 23. Well R4 should be added to the gas collection infrastructure.

An additional observation was that the technician did not use his personal gas alarm. Brookhill is known to have high levels of H₂S in addition to the methane and staff need to be aware of the hazards and to carry appropriate alarms.

Actions need to be taken as described in the full report.
