Assessment of monitoring returns between January and April 2014

Breaches of permit conditions:

Condition 2.7.1 - Leachate levels were allowed to rise significantly above the permitted levels during January. This was explained as being due to work being carried out to repair and replace pumps, however it was not reported at the time and the amount of leachate pumped to the effluent plant between January and March was significantly less than in previous months.

Condition 3.5.1 No figure has been reported for the leachate level in well R5 for February, March and April, and no explanation given.

The results of leachate depth monitoring include negative figures which cannot be correct. The method of calculating the leachate head should be checked - and also where the depth measurement is being taken from.

Condition 3.1.7 - A minor breach of the trigger limit for methane concentration in BH19 occurred in January. This was reported and action taken to reduce it and prevent a reoccurrence.

Note - for waste returns - Imported leachate should be reported against permit number EAWML 37207, The food waste and other waste stored on the newer transfer pad should be reported against EAWML 103574; and the wastes stored on the older transfer pad against permit number EAWML 100198.
