Reporting of Monitoring Data

Monthly reporting of the site's surface water monitoring is currently a requirement of the permit, however most permits now have a quarterly reporting requirement. During the next permit variation the reporting frequency will be formally changed however in the interim NRW will now accept quarterly reporting of the monthly surface water monitoring results (e.g. W1). The monitoring frequency will remain unchanged and any exceedance of limit will still need to be reported in accordance with the Schedule 1 notification requirements of the permit. **Action**

NRW will also accept results submitted in electronic format e.g. Excel, CSV etc. There is no longer a need to manually sign and scan each return.

We also request that all monitoring returns are cc to the site inspector when emailing them to the industry regulation mailbox.
