Q3 – July to August W1 and A6 Monitoring Submissions

Water: We have reviewed the three submissions (received 21st October 2016) for the surface water monitoring results for the W1 monitoring point, covering the above period. Based on the information provided there were no exceedances reported for the monitored parameters reported over this monitoring period, at the W1 monitoring point. (e3).

The three surface water submissions were submitted within the reporting deadlines specified by the permit (g4)

Air: We have also reviewed the monitoring submission for the A6 monitoring point, covering the July to August 2016 monitoring period. Based on the information provided, the emission from the A6 point was compliant with the site's specified emission limit, on the date of the monitoring

The report was received within the reporting deadline specified in this permit (g4).

Draft EPR permit

NRW are presently finalising a draft variation to incorporate a change to the process in ETL5. As part of this work the Tin Anode plant permit will be consolidated with the main Trostre plant permit and the permit updated. During this visit we discussed the current draft. A finalised copy of the draft will be issued formally for comment shortly.

It should be noted that the varied permit will include a new condition (4.2.2) to submit, on annual basis, a review of the monitoring data for the previous year. The deadline for this report is the 31st of January every year. It is likely that the above variation will be issued prior to the 31st of January 2017. If this is indeed the case we have agreed that an annual monitoring review will not be required in January 2017. The first submission can be made in January 2018 to cover the 2017 monitoring year.
