Condition 2.8.2 in the previous permit variation (V005) requires Valero to review their site protection and monitoring plan (SPMP) every 4 years. Valero choose to report their findings every year. The conclusions of the 2018 report will be reviewed with Valero during 2019/20. The general approach to reporting for 2018 has been to continue to report the 2018 data using the old permit variation (V005) and to start the 2019 data reporting using the latest variation reporting requirement (V006). The exception to this position has been the need to report the bubble data for 2018.

The 2018 report will be the last that is formally submitted as there is no formal requirement to submit this information now that the latest permit variation has been issued. However NRW will look at reviewing the ground water data on an annual basis.

The SPMP was received within the reporting periods that are specified in the permit - the SPMP report was received by email on 30 January 2019.
