Site visit to carry out routine inspection and discuss the application process for the surrender of the parts of the permit relating to Delyn Mill.

The main building housing the Delyn paper machine has been completely demolished and the area landscaped. The warehouse has been retained and will be used by Coleshill. A plan showing the reduced installation boundary will be included in the partial surrender application. A site survey has been carried out to demonstrate that there has been no impact from the manufacturing operations during the time it has been permitted.

The effluent plant is more stable, but needs close management to keep it running well. The reduced throughput since Delyn closed has helped in some aspects, but Coleshill produces several different grades and colours of tissue and wiper paper which all produce slightly different effluents. This also affects the sludge pressing process due to the different amounts of ash and fibre in the grades. The suspended solids content is the main parameter of concern when comparing effluent quality against the proposed BAT AELs; it is not consistently within the new limit. Work is already planned to improve monitoring of the activated sludge plant to make process control less reactive, and a possible improvement may be the installation of baffles in the final clarifier to prevent effluent from flowing directly across the tank and up and over the weir plates.

All water emissions have been within the permitted limits during the first quarter of 2014.

A minor breach of permit occurred when an operative forgot to carry out the daily COD measurement. He was fairly new to the job and will be re-trained and reminded of all the requirements. The effluent plant was stable at the time and all other parameters were within permitted limits. There is no limit on the COD.

The actions raised in last year's OMA audit have been completed.
