Environmental Noise Survey

A noise survey was carried out on the 9th July 2014 and results compared with previous years. Conclusions of report noted that there was an increase in noise levels of + 6dB and +3dB over background noise during day and night time respectively. Increase in noise levels reported of marginal significance. It is noted that noise mitigation measures continue on site in particular the installation of the homogeniser. Conclusions of report findings accepted.
