A) Air Quality Monitoring Data

Continuous Particulate Monitoring

Results for emission points A1 and A13 were fully compliant throughout the monitoring period.

An emissions breach was reported for point A12 on 14/04/13 which has been attributed to strong winds interfering with the CEM opposed to true emissions to atmosphere. Thank you for your part A & B notifications. Please can you provide further clarification as to how you believe the wind has affected the CEM - for example is it due to large particles re-circulating in the duct - possible link to the incident on 04/01/13?

Periodic Monitoring (Emissions to Air)

Emission points A1, A12 & A13 - all emissions compliant with permitted limits.

B) Emissions to Water

Nil return provided - no discharges (except surface water drainage) during this quarter.
