Site description

Tata Steel UK Ltd (Tata) operates an integrated iron and steel works at Port Talbot, Neath Port Talbot. The site is permitted as an installation under the Environmental Permitting Regulations (EPR). The steelworks has several identifiable permitted processes which are carried out sequentially across the installation to convert raw iron ores and coal to semi finished (slab) and finished steel products (such as hot rolled, pickled and oiled, cold rolled and annealed). The permit also covers coke making and the reception, stockpiling and blending of raw iron making materials. Two other companies, Cambrian Stone and Harsco, undertake separately-permitted slag handling and iron plating activities at the steelworks on Tata's behalf.

Purpose of visit/assessment

To discuss the use of recovered fuel oil from the Tata operated installation at Llanwern in the Port Talbot Morfa Coke Ovens.

First addressed in CAR 5849 and subsequently discussed further in CARs 5861 and 6058, Tata continue to investigate the effectiveness of different recovered fuel oils (RFO) as a coke oven density enhancer. In CAR 5849 we explained the End of Waste test outlined in EC Directive 2008/98/EC (the Waste Framework Directive)*. In CAR 5861 we outlined the parameters of a trial to discover if an RFO might meet the End of Waste test.

Tata propose to extend the trial to include a RFO won from its activities at Llanwern. Laboratory results have shown that, across a range of determinants the RFO is comparable to a virgin oil. Tata await results for Polychlorinated Biphenyls (PCB) and Fluorine concentrations from a third party laboratory. Tata must defer the commencement of the trial until these results are received and reported to us.

Tata may proceed with a **one month** trial under the same parameters outlined in in CARs 5849 and 5861.

Tata have indicated a desire to begin the trial on **Monday 13 June 2016**. Please confirm at the commencement of the trial.
