NRW's annual plan for the combustion sector included carrying out an Operator Monitoring Assessment (OMA) of the systems in use on large combustion plant. As Tata Steel has large combustion plant operating within the steelworks, then an OMA was needed to help contribute towards the overall NRW plan.

This audit sampled two boilers the Mitchell Boiler A53 and Boiler 6 (A52a) so that both continuous and discontinuous monitoring aspects could be audited as part of the OMA.

Tata Steel Port Talbot performed well over the four sections of the OMA, with an overall score of 78%, and passing all the critical elements contained within the audit. Provisions for monitoring (periodic and continuous) have been found to be at a good standard. There are certain elements where NRW has identified potential areas for improvement/gaps; in these cases recommendations, have been made which will address these shortfalls (and improve scores on subsequent OMA audits).
