This Compliance Assessment Report follows an assessment of routine monitoring returns for the period January - December 2017. and annual reports as submitted to NRW January 2018.

1. Emissions to Air (A1, A12 & A13)

Continuous particulate and 6 monthly extractive monitoring completed as required by the permit - all emissions compliant.

2. Emissions to Water (W1)

Two discharges were reported for 27/06/17 and 15/08/17 - all parameters compliant with permitted limits.

3. Annual Report & Performance Parameters

I have reviewed the annual report and note the comments and conclusions drawn and have no further comment,

Annual reports for water use, energy use, raw material use and selected waste production received - no issues noted.

4. Noise Assessment

I have reviewed the assessment and note that the report concludes that;

'at the nearest property on The Oval, the likelihood of complaints during the daytime and night time would be of marginal significance. However, it was considered unlikely that the Company would receive complaints during the daytime, due to the significant amount of construction work in the immediate area, also on Bridge Road.

Both the day and night time results indicated a difference of +7 dB over the background noise level. It was also noted that 'chiming' noise generated by the logs during the stripping of the pit activity appeared to have less of an impact due to the changes made at the lay down station. There were fewer 'chiming' noises generated and the noise was only just perceptible.

I note that the report adds an acoustic feature correction of 6 dB(A), presumably for impulsive noise, possibly including the charging of the furnace or the chiming of logs (or both). Please can you clarify.
